TITLE CONFIRMATION



CAT MUST BE TICA REGISTERED TO BE CONFIRMED. Titles are not confirmed on cats under 8 months of age. Kittens are automatically scored by the Executive Office. A kitten is any cat under the age of 8 months. A novice is any cat shown for the first time after the age of 8 months. Points are cumulative from the cat's first entry as a novice. To confirm a title, please complete Sections A, B, C and D. The owner's signature must be received in order to process the application. Submit all points earned in each show and record each ring on a separate line (each judge must be recorded on a separate line). Points are cumulative; balance of points from a previous title will be applied toward the next title. DO NOT duplicate previous points submitted. Return completed form(s) ONLY when the required points have been acquired for each title. Research and computation of your cat's points may be requested. In order to research your cat's points, you must fill out Section A and the Name of the Club(s) and Date(s) of each show to be researched in Section C; you will receive copies of this completed form and notice of titles which have been earned.

ALTERS: After altering, a cat may be confirmed for the next consecutive title (i.e., a Double Grand Champion may be altered and then shown as an alter and confirmed as a Triple Grand Champion Alter, etc.--this cat would hold titles of Champion, Grand Champion, Double Grand Champion, Triple Grand Champion Alter, etc.) OR the cat may start over as a Novice in the Alter Class and earn points toward the titles of Champion Alter, Grand Champion Alter, etc. (i.e., a Double Grand Champion may be altered and then shown as an alter and confirmed as a Champion Alter, Grand Champion Alter, etc.--this cat would hold titles of Champion, Grand Champion, Double Grand Champion, Champion Alter, Grand Champion Alter, etc.).

The SHOW RULES, ARTICLE SEVEN - REQUIREMENTS FOR TITLES, delineate the requirements for titles.

Show Rule 7.4 states: "SUPREME GRAND CHAMPION/SUPREME GRAND CHAMPION ALTER/SUPREME GRAND MASTER: An eligible male or female or an eligible neuter or spay cat registered in TICA shall be entitled to the prefix "SUPREME GRAND CHAMPION" or "SUPREME GRAND CHAMPION ALTER", and an eligible, TICA registered household pet, after attaining the title of Quadruple Grand Champion, Quadruple Grand Champion Alter, or Quadruple Grand Master respectively, shall be entitled to the prefix "SUPREME GRAND CHAMPION", "SUPREME GRAND CHAMPION ALTER" or "SUPREME GRAND MASTER" by winning an additional 2,000 points with at least one additional award being Best Cat of either format. However, in such isolated areas as Alaska, Hawaii and Japan, cats are entitled to the title "Supreme Grand Champion", "Supreme Grand Champion Alter" or "Supreme Grand Master" by earning 1,000 points with at least one additional award being Best Cat of either format." NOTE: Your cat may achieve the points required for Quad Grand Champion / Quad Grand Champion Alter / Quad Grand Master at a Saturday Show and then, the next day, achieve the Best Cat that will count toward his/her Supreme Grand Champion / Supreme Grand Champion Alter / Supreme Grand Master, however, if some of the points for your cat's Quad are achieved on Saturday, the Best Cat will count toward his/her Quad Grand Champion / Quad Grand Champion Alter / Quad Grand Master ONLY.

Show Rule 12.4 states: "The Top 5 format MUST BE USED WHEN 20 OR FEWER CATS, KITTENS, ALTERS OR HOUSEHOLD PETS ARE COMPETING. Entries not eligible for competition under Show Rules 15.2 and/or 15.4 may be "presented" in the ring, where ineligible for competition, and shall be counted when determining the number of entries present and competing."

Show Rule 12.5 states: "The Top 10 format REQUIRES A MINIMUM OF 25 CATS, KITTENS, ALTERS OR HOUSEHOLD PETS COMPETING. Entries not eligible for competition under Show Rules 15.2 and/or 15.4 may be "presented" in the ring where ineligible for competition, and shall be counted when determining the number of entries present and competing."
